Dear Secretary of Veterans Affairs Robert McDonald:

Please listen. I believe the attached letter plants a lot of confusion and is intended to cover over a set up to takeaway my 2012 poverty pension and make it appear as my fault. If this is done my annual income drops from \$12,876 to \$6,084 and I'm dead.

Please see the two attachments. I only have only one benefit outstanding and that is the VA poverty pension that I've had since 2012. The only qualifications for a veteran to qualify for that is that they be over 65 and have an income below the poverty line. It is supposed to be automatic. It is not supposed to be adjudicated. I am still below the poverty line and am still over 65.

I have no applications outstanding in the Arizona Department of Economic Security (DES) or the Arizona Health Care Cost Containment System (AHCCCS). If whoever sent this letter believes I do please have them send me a copy. Anything to do with DES or AHCCCS is irrelevant. I can't think of anything relevant in this letter unless it is a set up.

We need the information listed below to decide if you can qualify for the programs for which you have applied. Contact us if you have trouble getting the information we are requesting. We may be able to help. You must give us this information no later than 06/18/2015. There are several ways for you to give us the information we are asking for below:

1. Log in to your Health-e-Arizona Plus account at 'www.healtharizonaplus.gov' to scan, upload, or email information. OR
2. Fax your information using the attached fax coversheet to 1-888-372-8777. The fax coversheet has a barcode that identifies your case. OR
3. Mail your information to: AHCCCS. 801 E. Jefferson Street. MD 3800, Phoenix, AZ 85034

If you cannot get this information to us by the due date you may be able to get more time. You can request more time by calling the number above.

If we do not get the information and we do not hear from you, we will deny your application or stop/change your benefits."

I believe this letter is a set up to take away my VA economic pension because that is the only benefit I receive besides social security and there is a pattern of disempowering me. This would reduce my annual income from \$12,876 to \$6,792.

Why won't you allow me to get my 2003 Power of Attorney and Living Will out of the VA system? Why the extreme avoidance of accountability?

Why the continued discrepancy between the number of medicine fills stated on my medicine bottles and the number of fills I actually receive? I receive one less fill than it says on the bottle. 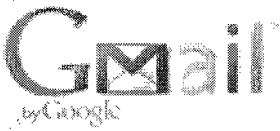
